Story of the Lake Erie Basin Committee (LEBC)

This is part 1 of a 3 part summary of the history of the Lake Erie Basin Committee's work. Unfortunately, it has just disbanded, but it has much to be proud of.

When Carolyn Moore lived in North Dakota in the 1950's she participated in an inter-League study of the Red River. The times, they were a changing . . . and there was a new interest in things like water quality and air pollution. Carolyn moved to Ohio in the early '60's, bringing her expertise to a study of the Ohio River Basin that Ohio Leagues were doing. As she learned more, she became concerned about Lake Erie, and asked a LWVUS staffer what could be done. She was told "it takes just one interested person to start", so that's what she did. She wrote to Leagues in the Lake Erie Basin and set an organizational meeting for March 3, 1963. Fifty-five women from 28

Michigan League Positions and Program Planning

Each January our League holds a special meeting to review the positions of our organization at either the state or national level. These positions form the basis of the League's ability to testify for or against proposed legislation, and are usually written in general language reflecting the consensus of the membership around the country.

On January 19 we will review the state positions. Former Michigan League President Sue Smith chairs a committee of members from around Michigan to re-write part of the Taxation and Budget positions. The Grosse Pointe League met in November to review state financial procedures and answer consensus questions. The meeting was well attended and Connie Frey presented the questions with a clear, informative power point. We submitted our consensus report, and the final wording of the position will be sent out before the state convention in May.

The State Board is not recommending re-studies of any positions in the upcoming biennium since it feels the positions are adequate to testify on issues likely to arise. Nationally the League is mostly focused on voting rights and money in politics. In Michigan our Leagues have become more informed on redistricting issues, and we have a strong history of work on environmental policy and juvenile justice.

Our League has local positions, too. Some harken back to the reorganization of Wayne County government, and some reflect environmental work in the Lake Erie Basin. Others responded to local issues like inter-community planning or changes in the library system, so that our League could speak with one voice. Voter Education Presentation Available to League Members re: Gerrymandering & Voting Rights

Leagues representing Michigan, Ohio, Pennsylvania and New York showed up.

Discussion included 11 reports on "My Area's Chief Water Problems" and the question "What might an Inter-League group do?" Background on other Inter-League River Basin studies -the Missouri, Columbia, Susquehanna, Delaware - informed their discussion. They formed a steering committee and went to work.

The steering committee drew up a plan to (1) build public understanding of Lake Erie water problems (2) work toward possible LWV regional consensus and action in line with LWVUS positions on water (3) prepare and distribute a publication on Lake Erie as it affects the people in the basin. Subcommittees were assigned to research different aspects, and their work, along with selected background material was sent to Local leagues for study and input. The resulting preliminary document, Pollution - the Other Side of Progress, gave members a tool to prepare testimony at hearings, and the consensus process produced a regional position statement in 1967. LEBC raised \$5000 to publish a fully developed book entitled Lake Erie: Requiem or Reprieve?, and sold it for \$1.00 each.

In March of 1967 LEBC organized a two day educational conference entitled Politics of Planning which drew government and industry representatives as well as League members. League sub groups around the area began to specialize in local water issues, such as New York's League testifying against a plan to drill for oil and gas in Eastern Lake Erie.

Holiday Cheer

The recent presidential and congressional elections and their aftermath have put our national election process and voting requirements and practices in the public spotlight, offering an optimal opportunity for the League to do further voter education in the new year. An informative PowerPoint presentation with script is now available dealing with 2 important current voting issues: Gerrymandering and Voting Rights.

Many citizens may be unaware of how the current extreme gerrymandering of Congressional districts contributes to the political polarization in Washington. Inaction on important problems, political gridlock, and failure of compromise which facilitated government in the past leave many Americans frustrated. Understanding why and how Congressional districts lines are now drawn to the advantage of one party and the detrimental effects on our political process is the first step toward a solution which several states have undertaken.

Voting rights was the focus of the League of Women Voters national convention last May in Washington, DC. The theme, "Making Democracy Work for All" highlighted voter protection and voter suppression. The PowerPoint explores the history of voting rights in America, the 1965 Voting Rights Act, and the Supreme Court's Shelby decision (Shelby County v Holder) striking down parts of the VRA and leading to a wave of burdensome voting restrictions, some of which have been struck down by federal courts as unfairly targeting minorities.

We are happy to report MCVS has found a home with the **Mt. Clemens Public Library at 150 Cass Ave, Mt. Clemens** and have monthly meetings scheduled there throughout 2017. **Our unit voted to change its regular meeting date from the first Monday to the fourth Thursday of the month.**
