

# LWV US Statement on Immigration

#### January 2017

From the Prez...

These certainly are not dull times. I think it is important for me to clarify what the League being "non-partisan" means. Certainly, it does not mean that we do not have opinions (sometimes strong ones) or the ability to act. Our heritage is that almost 100 years ago, our founders risked their lives to act. Being meek and mild is not in our DNA.

Here is the definition from the dictionary of "partisan": a strong supporter of a party, cause, or person. Synonyms include: supporter - follower - adherent - devotee - champion - fanatic - fan

As reference, an excerpt from the LWVGP Non-Partisan Policy states: •

"The purpose of the LWV is to promote political responsibility through informed and active participation of citizens in government. The LWV is nonpartisan in that it does not support or oppose any political party or candidate; it is political in that it takes positions on selected government issues after member study and agreement.

"The LWV recognizes the role of political parties in our form of government and believes that participation in the activities of political parties is an essential ingredient of its citizen responsibility. The LWV urges its members to be politically active."

Also important to be aware, LWV's board members have additional restrictions for guaranteeing that their actions adhere to the League's nonpartisan policy. And don't forget, while individual members' informed and active participation is encouraged, only the Board may speak for the League as an organization.

So be active and don't back off from having opinions, expressing them, and working to further them in the political arena!! Recognize that in the election process, the League can't endorse candidates or parties but can work diligently promoting its issues. And this does not mean that we are silent or inactive when those candidates become our elected officials.

#### The League of Women Voters

president, Chris Carson, issued the following statement in response to President Trump's immigration ban:

The League is opposed to deportation of non-criminal undocumented immigrants.

The LWV supports cities, towns, counties and states that make a decision not to cooperate with federal deportation and enforcement actions that include non-criminal undocumented immigrants.

Moreover, the Trump Administration's orders are of dubious legality.

It is simply wrong, and a perversion of the American system of justice, for the Executive Branch to refuse to obey federal court orders.

The LWV is opposed to discrimination, including discrimination in immigration, based on religion. The Trump Administration's orders appear to be targeted at Muslims and immigrants from majority-Muslims nations.

We would like to remind all our members that we are faced with many challenges to our positions and the League is involved in serious efforts to address them. Among these, we spent last weekend anticipating the issuance of an Executive Order investigating 'voter fraud'. We continue to monitor this situation and are ready to issue a statement if that occurs. We also continue our efforts to lobby on ACA in Congress. Everybody in the country is scrambling to keep up.


#### **Forum**

Remember Carolyn Moore, founder of LEBC? In 1969 she gave a special report to the International Joint commission emphasizing the need for implementing a phosphorous control to minimize its presence in detergents by 1972. On December 3, 1969, she delivered a statement before the IJC saying "drilling for gas and oil in Lake Erie is contrary to the public interest. Pollution can occur from such activities. We lack the means to cope

#### **Taxation & Budget/Gov't Finance Position Consensus**

There was a great turnout of over 20 members for the Nov. Taxation and Budget LWVMI position consensus meeting at the home of Jan and Tom Wells. Jan also secured the projector and screen for the power point that facilitated the discussion. Ann Nicholson provided background on the role of consensus in this restudy of a state position. The process began when the delegates at the 2015 state LWV convention approved this restudy as part of the '15-'17 program.

Questions were provided to discover members' opinions about proposed changes to the current position. Pro and con statements show different points of view to encourage members to express their opinions about different government finance issues. Reaching consensus does not mean vote counting.

In most areas the group answered positively to the questions. There was no consensus (neither being for or against) the question about adding a sales tax to more service categories. Now 34 out of 164 potential categories are taxed. For some questions there was specific concern with certain word choices, although there was agreement with the basic idea.

Our answers to the questions and comments will be sent to the state office where all the reports reflecting the participants' input will be used to develop the final wording of the position. Then the position becomes a part of the '17-'19 program to be voted on by the delegates at the May 2017 state convention.

# **Macomb County Voter Services Report**

MCVS is off to a great start this year with an increased interest in meeting the voter education needs of our communities! We know this because there is quite an increase in membership and attendance! The bulk of our membership attended our last meeting on January 26th as well as the addition of six new faces. We had to ask the library for more

with it . . . We are opposed to drilling." That year she received the National Conservation Award given by General Motors.

In January of 1970 a New York subcommittee member stated at a hearing to permit deep well disposal that "in all cases where the state is considering granting a deep well permit, the public welfare must be considered first; economic advantages to industry must take second place. The cost of safe guards must be built into the costs of the products. If people want the advantages of a technical, industrialized society, they must be willing to pay for them."

The Lake Erie Letter, published up to three times annually from 1969-1988, focused on a single water related issue each time. Topics ranged from oil and gas drilling to river dredging to disposal of toxic waste. In 1973 LEBC reorganized into three regional subsections. Total membership that year was 69 Leagues in 5 states representing about 7800 members. During this time 9 Leagues in Wayne and Oakland County formed a River Rouge Basin Committee to study wastewater pollution and flooding problems.

LEBC continued to testify at public hearings on pollution abatement, power plants, energy, landfills, ground water issues, coastal management, and water diversion using the positions arrived at in 1967.

During its November 30,2016 meeting, the LWVGP Board voted Kathy Poore in as the Director of MCVS. Nance Halle has offered to chair VOTE411, Terri Serra has offered to assume the role of recording secretary, Nancy Duemling has offered to serve as Membership Chair, and Katherine Labuhn has offered to chair Public Relations.

Of course, we still plan to carry out the core functions of the MCVS unit: VOTE411, Candidate Forums, High School Intervention, Redistricting and Voter Registration. Nance has already begun the process of identifying communities with upcoming elections and will lead the effort to get those candidates in the VOTE411 system this spring.

There is an interest in working with other organized groups in the community. We hope to set up a system to facilitate that effort as well.

Our next regular meeting is on February 23rd, 7PM at the Mt. Clemens Public Library at 150 Cass Ave, Mt. Clemens.

# **Vote 411.org Election Report**

I am pleased to report the following information from Megan Brown, Elections Coordinator for the National <u>LWV.</u>

<u>VOTE411</u> was a huge success, with nearly 6 million sessions from Jan 1st through Nov 8th, and over 2.7 million of those sessions included the online voters' guides. That represents a 279% increase in sessions nationwide to voters' guides on VOTE411 as compared to 2012, the last comparable election.

The LWVUS promoted VOTE411 throughout 2016 and undertook an outreach program during the final months leading up to Election Day through their new customized widget, social media promotion and much more. They rely on the localized candidate information in every local community where Leagues develop voters' guides. Megan recently surveyed all local leagues asking them to describe the ways they spread the word about VOTE411 in their communities. We participated in the survey and look forward to receiving the results.

In Michigan, use of Vote 411 in 2016 was 2.4 times the use in the previous presidential election. Every League had increased users; overall there were 218,066 sessions. Leagues in Michigan also held more than 130 candidate forums.

Vote 411 provided information on national and state races to all Michigan voters. Those areas with local Leagues could also get information on races from county officials to school boards in their area.
